The unaudited post-tax net asset value (NAV) as at 31 March 2014 was \$1.50 per share (28/02/14 \$1.55).

The NAV was calculated on a liquidation basis using last sale price to value investments. Investments were stated at net market value and after provision for tax on both realised and unrealised income and gains. The share price at 31 March 2014 was \$1.795.

As at 3 April 2014, the Company was 10% short individual shares and index futures. The currency exposures were: US dollar and Hong Kong dollar 50%; Euro and other European currencies 29%; Asian currencies excluding Japanese yen 14%; Canadian dollar 3% and Japanese yen 3%. We have no exposure to the Australian dollar.

PMC's investment portfolio is invested in a similar manner to that of the unlisted Platinum International Fund ("PIF"). The daily unit price movement of PIF is a broad indicator (but not a perfect match) of the daily movement in PMC's NAV.
