Prior to making a decision to switch (and/or invest in a new Fund / Unit Class), you should consider the Funds' Product Disclosure Statement No.11 ("PDS") and the specific characteristics and risks of the Fund / Unit Class you are switching to (applying to invest in). Switching between Funds / Unit Classes may also give rise to tax consequences and it is recommended that you check the tax implications with your tax adviser before switching.
