In June 2023, Platinum experienced net outflows of approximately \$232 million. This included net outflows from the Platinum Trust Funds² of approximately \$162 million. The net outflows do not include the impact of the distribution to unit holders of \$566 million or the distribution re-investment of \$156 million.

Performance fees

Platinum is entitled to estimated performance fees of approximately \$1m for the 2023 financial year (2022 financial year: \$7m). Performance fees (if any) will fluctuate significantly from year to year.

Market update

Platinum currently expects 2023 financial year profit after tax to be broadly in line with consensus estimates (which range from \$77m to \$82m)³ but with lower performance fees (as noted above) and higher expenses (due to increased variable compensation costs arising as a result of strong
