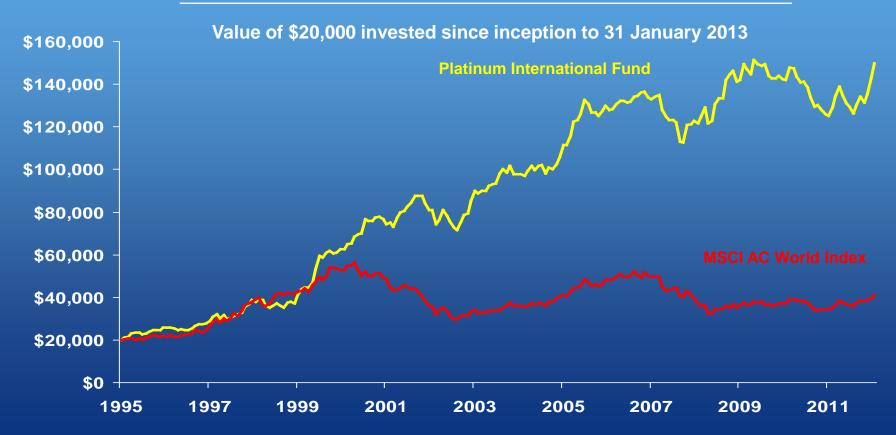

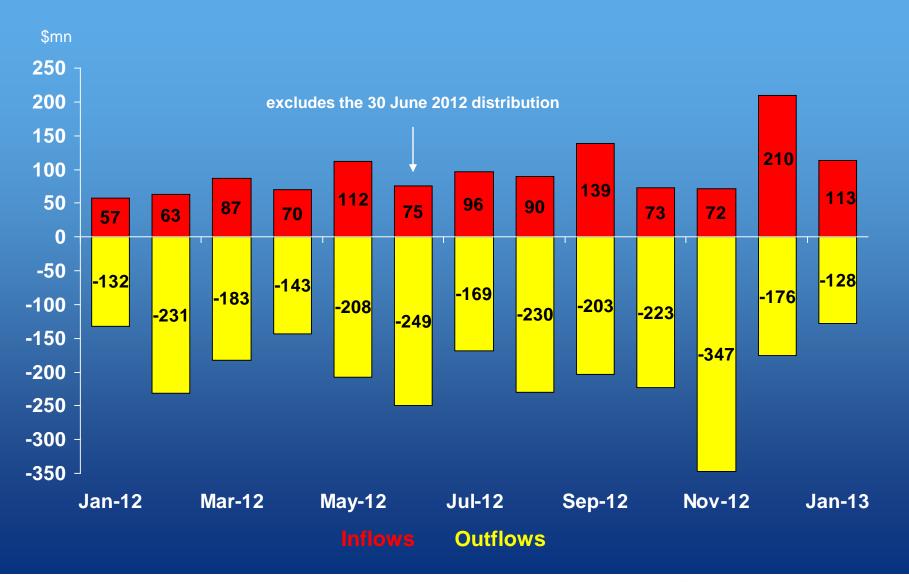

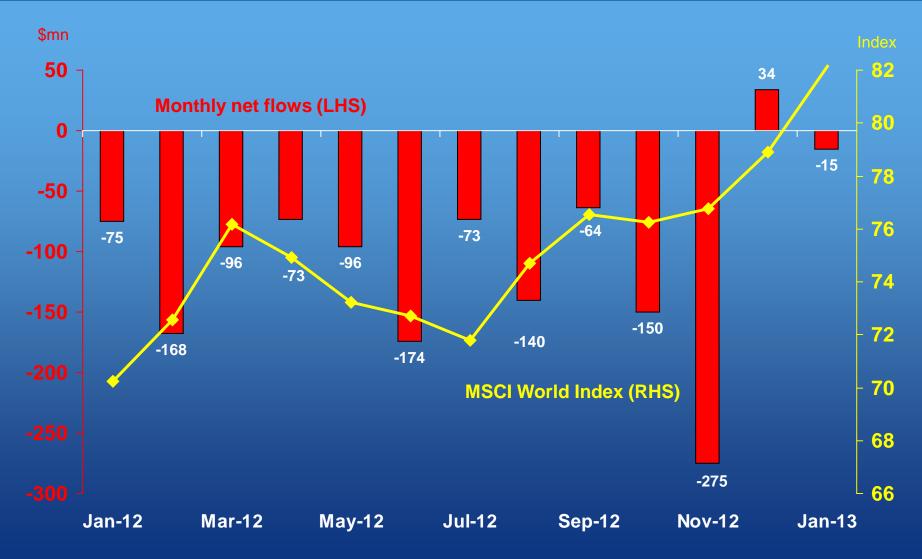
Platinum Trust Funds – monthly inflows and outflows

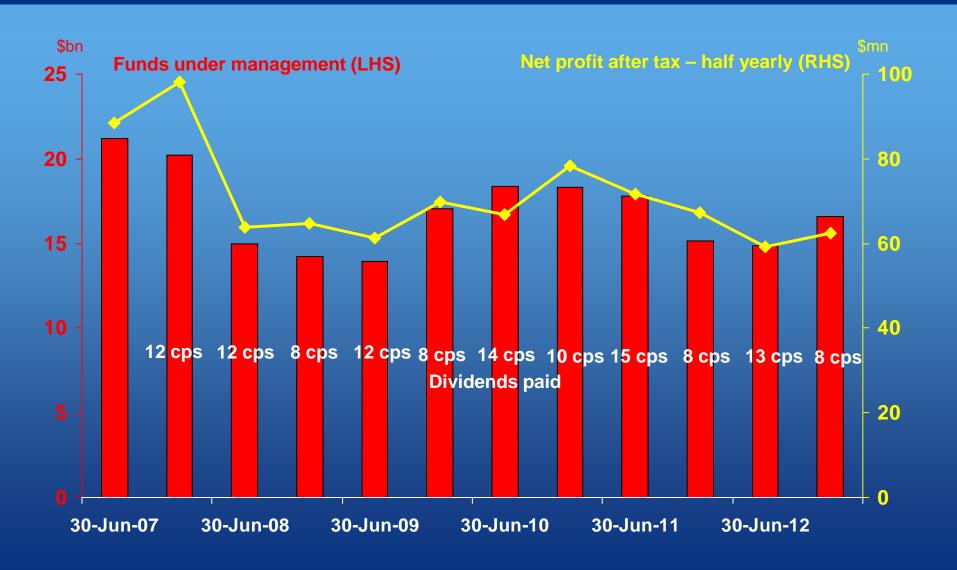
Platinum Trust Funds – monthly net flows with MSCI Index overlay
