In June 2024, Platinum experienced net outflows of approximately \$234 million. This figure includes net outflows from the Platinum Trust Funds<sup>2</sup> of approximately \$195 million. The net outflows do not include the impact of the distribution to unit holders of \$218 million or the distribution re-investment of \$72 million.

## Market update

Platinum Asset Management Limited has made good progress on reducing expenses in recent months with turnaround program implementation cash and non-cash costs in the 2024 financial year ("FY24") expected to be broadly in line with the previously announced estimate of circa \$21 million.

Investment gains and other income items (including interest) for FY24 are expected to range between \$9 million and \$11 million.

The Company did not earn any performance fees in the second half of FY24.
