Note. the number of convertible securities converted during the period was actually 722,876 PTMAA rights. However, the number included in this notification has been adjusted downwards to 716,566 i.e. by 6,310 PTMAA rights as the prior notification incorrectly overstated the number of PTMAA rights that had been issued by 6,310.

In addition to the 722,876 PTM ordinary shares transferred in satisfaction of the exercise of 722,876 PTMAA rights during the quarter, a further 546,867 PTM ordinary shares were transferred to satisfy the dividend equivalent payments attaching to the 722,876 exercised PTMAA rights.
