

## PLATINUM GLOBAL FUND

### Withdrawal Form

**This form is to be used for direct investments in the Platinum Global Fund and not if you have invested via the mFund Settlement Service (mFund).**

Use this Form to make a request to withdraw (all or part of) your investment in the Platinum Global Fund ("**Fund**"). The minimum withdrawal amount is A\$10,000 (or the entire investment balance in the Fund if the withdrawal would cause your investment in the Fund to fall below the minimum balance of A\$10,000).

Under the Regular Investment Plan, a minimum balance of A\$10,000 is required to keep your investment in the Fund open.
