We indemnify Platinum (together with its officers, directors, employees and agents) (collectively, the “Platinum Indemnified Parties”) from and against any and all claims, liability, losses, costs, expenses or damages (including legal costs on a full indemnity basis) (“Loss”) incurred or suffered by the Platinum Indemnified Parties, arising directly or indirectly out of, or resulting from, any breach under or in connection with this form, including but not limited to, any Loss arising out of the negligence, fraud or wilful misconduct of our employees, Authorised Users, contractors, representatives and/or agents.
