# Platinum Asia Investments Limited (PAI) - Implementation of Dividend Reinvestment Plan

At the time of the PAI Initial Public Offer, the Board indicated that it may implement its Dividend Reinvestment Plan (DRP) at any time.

The Board is pleased to inform shareholders that its DRP has been activated. This will offer shareholders the opportunity to reinvest all or part of any future cash dividends declared by the Board in additional PAI shares.

The DRP will provide investors with a convenient means for shareholders to increase their investment in PAI without incurring brokerage, commission or stamp duty fees.

The activation of the DRP is simply an administrative step to ensure that when we do pay a dividend we are able to handle the DRP efficiently. *It does not mean that the payment of a dividend is imminent.* The purpose of this letter is to provide shareholders with plenty of time to register their interest, as there is usually only a short window from the date any future dividend is declared to the date that shareholders are allowed to register their interest.
