The estimated distribution for PAXX as at 27 June 2022 is \$0.138636 per unit.

## **Important Information**

You must be a registered unitholder of PAXX as at the record date to be eligible to receive a distribution.

Distributions will be calculated based on the number of units held by you as at the record date i.e. your distribution entitlement will not be pro-rated having regard to the duration of your investment in PAXX during the financial year. It is important to note that the estimated distribution calculated for PAXX will lead to an equivalent reduction in PAXX's unit price from the ex-distribution date.

If you have not provided your bank account details or made an election to participate in the Dividend Reinvestment Plan ("**DRP**") by 5pm on 30 June 2022, your distribution will be automatically reinvested in accordance with the constitution of PAXX and the rules of the DRP.
