B. Items for Approval

Resolution 1 - Re-election of Jim Clegg as Director

To consider and, if thought fit, to pass the following resolution as an ordinary resolution:

"That Jim Clegg, retiring from the office of Director in accordance with rule 46(a) of the Company's Constitution and being eligible for re-election, be re-elected as a Director of the Company."

Resolution 2 - Election of Ian Hunter as Director

To consider and, if thought fit, to pass the following resolution as an ordinary resolution:

"That Ian Hunter, having been appointed to the office of Director in accordance with rule 45(d) of the Company's Constitution and being eligible for election, be elected as a Director of the Company."

Resolution 3 - Adoption of the Remuneration Report

To consider and, if thought fit, to pass the following resolution:

"That the Remuneration Report of the Company for the financial year ended 30 June 2021 be adopted."

Note: The vote on this item is advisory only and does not bind the Company or its Directors.

EXPLANATORY MEMORANDUM

Introduction

This Explanatory Memorandum is intended to provide shareholders with important background information in relation to each item of business. It should be read in conjunction with the Notice of Meeting.

A. Financial and Statutory Reports (not voted on)

The Company's Financial Report, Directors' Report and Auditor's Report for the financial year ended 30 June 2021 will be laid before the AGM, as required by section 317 of the *Corporations Act 2001* (Cth) (**Corporations Act**). The Corporations Act does not require a vote of shareholders on these reports.

The Company's Annual Report for the financial year ended 30 June 2021 (which includes the Financial Report, Directors' Report and Auditor's Report) is available on the Company's website at: www.platinum.com.au/PlatinumSite/media/Financial-Statements/pcl_0621.pdf

Shareholders will be given a reasonable opportunity during the AGM to ask questions and make comments in relation to the financial and statutory reports, and the business and management of the Company.

Shareholders will also be given a reasonable opportunity to ask a representative from the Company's auditor, PricewaterhouseCoopers, questions relevant to the conduct of the audit, the preparation and content of the Auditor's Report, the accounting policies adopted by the Company in the preparation of financial statements and/or the independence of the auditor in relation to the conduct of the audit.

B. Items for Approval

Resolution 1 - Re-election of Jim Clegg as a Director

Rule 46(a) of the Company's Constitution provides that a Director may not hold office for a continuous period in excess of three years or past the third AGM following the Director's appointment, whichever is longer, without submitting for re-election.

Mr Clegg has been an independent Non-Executive Director of the Company since 5 June 2015.

Mr Clegg is retiring from office, and in accordance with ASX Listing Rule 14.4 and rule 46(a) of the Company's Constitution, offers himself for re-election. A summary of Mr Clegg's qualifications and experience is detailed below.

Jim Clegg BRurSc (Hons), DipAgEc Independent, Non-Executive Director since 5 June 2015

Mr Clegg has over 35 years' of experience in the financial services industry. Mr Clegg was the founding managing director of Pembroke Financial Planners and was formerly a director of Godfrey Pembroke, Berkley Group and Centric Wealth. He was also formerly a trustee of The Walter and Eliza Hall Trust and is currently a director of Platinum Asia Investments Limited.

Recommendation

Having regard to Mr Clegg's knowledge, skills and experience, each member of the Board (other than Mr Clegg who has abstained) unanimously recommends that shareholders vote in favour of the re-election of Mr Clegg as a Director.

Resolution 2 - Election of Ian Hunter as a Director

Rule 45(d) of the Company's Constitution provides that the Directors may at any time appoint any person as a Director either to fill a casual vacancy or as an addition to the Board. Any Director appointed under this rule 45(d) may hold office only until the end of the next annual general meeting of the Company and is then eligible for election at that meeting but is not to be taken into account when determining the number of directors who are to retire by rotation at the meeting.

Mr Ian Hunter was appointed as an additional independent Non-Executive Director by the Board on 9 September 2021. The Directors consider that, if elected, Mr Hunter will qualify as an independent Non-Executive Director. A summary of Mr Hunter's qualifications and experience is detailed below.

Mr Ian Hunter BA, LLB, MBA

Mr Hunter has worked in the finance and investment industry since 1975, having worked at several banks and most latterly at Bankers Trust Australia where he was a director and an executive vice-president. Mr Hunter has also formerly held various directorships at a number of Australian listed companies, and is currently a director of Ironbark Capital Limited and Platinum Asia Investments Limited.

Recommendation

Having regard to Mr Hunter's knowledge, skills and experience, each member of the Board (other than Mr Hunter who has abstained) unanimously recommends that shareholders vote in favour of the election of Mr Hunter as a Director. If elected, Mr Hunter will join Ms Towers, Mr Clegg and Mr Morath as the Company's Non-Executive Directors, each of whom are

also Non-Executive Directors of Platinum Asia Investments Limited (PAI). Given the common issues faced by the Company and PAI, not least in relation to legal, risk and compliance matters, the Board is of the view that there are many potential benefits to having a common board of directors across both companies. In recognition of the efficiencies of a common board of directors, the Company's current directors' fees have been reduced, such that with Mr Hunter's appointment to the Company's Board, the aggregate directors' fees paid by the Company's shareholders will remain unchanged. Accordingly, the Board is of the view that Mr Hunter's appointment is in the best interests of shareholders.

Resolution 3 - Adoption of the Remuneration Report

The Remuneration Report of the Company for the financial year ended 30 June 2021 forms part of the Directors' Report and is set out on pages 21 to 24 of the Company's Annual Report, which is available on the Company's website at: www.platinum.com.au/PlatinumSite/media/Financial-Statements/pcl_0621.pdf

A summary of the Remuneration Report for the financial year ended 30 June 2021 is as follows:

- The Company had three key management personnel ("KMP"), being the Directors of the Company.
- The aggregate annual remuneration paid by the Company to the Chairperson during the year was \$65,700 (including superannuation).
- The remuneration paid by the Company to each of the other Non-Executive Directors was \$60,225 (including superannuation).
- There has only been one increase in base pay for the Chairperson and other Non-Executive Directors in the last 16 years.
- The Company does not pay bonuses to any of its Directors

Shareholders will be asked to vote on a resolution to adopt the Remuneration Report during the AGM. In accordance with section 250R(2) of the Corporations Act, the vote on the resolution is advisory only and does not bind the Board or the Company.

At the 2020 AGM, the Remuneration Report was approved without a 'no' vote of 25% or more. If the Company receives a 'no' vote of 25% or more in relation to the Remuneration Report at two successive AGMs, a spill resolution will be put to the shareholders at the second AGM. In accordance with section 250W of the Corporations Act, if the spill resolution is passed with 50% or more of the votes cast, the Company will, within 90 days of the spill resolution being passed, hold a spill meeting to vote on whether to keep the Directors.

Voting Exclusion Statement

The Company will disregard any votes cast on Resolution 3 (in any capacity) by, or on behalf of, the following persons:

- a member of the Company's key management personnel (**KMP**) whose remuneration details are included in the Company's Remuneration Report for the financial year ended 30 June 2021; and
- a closely related party of such a KMP.

However, a person described above may cast a vote on Resolution 3 as a proxy if the vote is not cast on behalf of a person described above and either:

- the proxy appointment is in writing that specifies the way the proxy is to vote (e.g. for, against, abstain) on the resolution; or
- the vote is cast by the Chairperson of the AGM and the appointment of the Chairperson as proxy:
 - does not specify the way the proxy is to vote on the resolution; and
 - expressly authorises the Chairperson to exercise the proxy even if the resolution is connected directly or indirectly with the remuneration of a member of the KMP.

KMP are those persons having the authority and responsibility for planning, directing and controlling the activities of the Company either directly or indirectly. The KMP of the Company are specified in the 2021 Annual Report and are its Directors.

A closely related party of a KMP includes:

- a company that the KMP controls;
- the KMP's spouse, child or dependent (or a child or dependent of the KMP's spouse); or
- anyone else who is a member of the KMP's family and who may be expected to influence, or be influenced by, the KMP, in the KMP's dealing with the Company.

Recommendation

The Remuneration Report forms part of the Directors' Report which has been approved in accordance with a unanimous resolution of the Company's Board. The Board unanimously recommends that shareholders vote in favour of the adoption of the Company's Remuneration Report for the financial year ended 30 June 2021.

VOTING INFORMATION

Entitlement to participate and vote during the AGM

In accordance with regulation 7.11.37 of the Corporations Regulations 2001(Cth), the Board has determined that those shareholders registered as holding the Company's shares as at **7:00pm (AEDT)** on **Tuesday 26 October 2021** will be entitled to participate and vote at the AGM.

How to vote

If you are a shareholder entitled to participate in and vote during the AGM, you can vote your shares directly in one of the following ways, by:

- voting your shares online prior to the AGM at www.linkmarketservices.com.au using your Securityholder Reference Number (SRN) or Holder Identification Number (HIN), which is set out on the enclosed Proxy Form;
- appointing a proxy to participate and act on your behalf at the AGM by completing the enclosed Proxy Form and returning the Proxy Form in accordance with the lodgement instructions below; or

Appointing a proxy

If you are a shareholder entitled to participate and vote, you may appoint a proxy to participate and vote on your behalf at the AGM. A proxy may be an individual or body corporate and is not required to be a shareholder of the Company. A shareholder who is entitled to cast two or more votes during the AGM, may appoint two proxies and may specify the percentage or number of votes each proxy is appointed to exercise. Where a shareholder appoints two proxies but does not specify the percentage or number of votes each proxy may exercise, each proxy may exercise half of the shareholder's votes. Fractions of votes will be disregarded.

A shareholder entitled to participate and vote, may direct their proxy on how to vote on the proposed resolutions by following the instructions on the Proxy Form that accompanies this Notice of Meeting. If the shareholder appointing the proxy directs the proxy on how to vote on a proposed resolution, then the proxy may only vote in the way so directed. If the shareholder does not direct the proxy on how to vote on a proposed resolution, then the proxy may vote on that resolution as the proxy thinks fit, subject to the voting exclusions outlined in the Explanatory Memorandum.

If you wish to appoint a proxy, you must complete the Proxy Form accompanying this Notice of Meeting and lodge the Proxy Form using one of the methods listed under the Lodgement section above. Alternatively, you can appoint a proxy by completing the Proxy Form online at www.linkmarketservices.com.au. You will need your Securityholder Reference Number (SRN) or Holder Identification Number (HIN), which is set out on the enclosed Proxy Form.

Your Proxy Form must be received by the Company's share registrar, Link Market Services, no later than 10:00am (AEDT) on Tuesday 26 October 2021. Proxies received after that time will not be effective for the AGM.

Corporate Representatives

A body corporate, which is a Shareholder or which has been appointed as a proxy of a Shareholder, may appoint an individual to act as its representative during the AGM. The appointment must comply with the requirements of section 250D of the Corporations Act. An Appointment of Corporate Representation Form is available from the Company's share registrar (phone 1300 554 474) or online at www.linkmarketservices.com.au/corporate/resources/forms.html. The representative should deliver a properly executed Appointment of Corporate Representation Form or other document confirming its authority to act as the company's representative, to Link Market Services at vote@linkmarketservices.com.au prior to the AGM.

Undirected proxies and Chairperson's voting instructions

If you appoint the Chairperson as your proxy and have not directed the Chairperson how to vote, you are authorising the Chairperson to cast your undirected proxy in favour of all proposed resolutions, which are set out in this Notice of Meeting. The Chairperson intends to vote all such undirected proxies in favour of all resolutions.

Proxies in favour of KMPs

If you appoint a Director (other than the Chairperson) or any closely related party of such as your proxy, they will not be able to vote your proxy on Resolution 3, unless you have directed them how to vote.

All resolutions by poll

It is intended that voting on each of the proposed resolutions at the AGM will be conducted by a poll.

Shareholder questions

You may ask questions during the AGM about any of the resolutions being considered during the AGM or general questions about the Company's management or performance. You may also ask questions of the Company's auditor about the content of the Auditor's Report or the conduct of the audit.

During the AGM questions may be submitted via the online platform. Shareholders will need their SRN or HIN to lodge a question via the online platform. Questions may also be submitted during the AGM by voice using the teleconference facility during the meeting. Shareholders will need to contact Link Market Services on 1800 990 363 or +61 1800 990 363 prior to the AGM to obtain a personalised PIN number to ask a question via the telephone. 



1. Get a Voting Card

To register to vote – click on the 'Get a Voting Card' button.

This will bring up a box which looks like this.

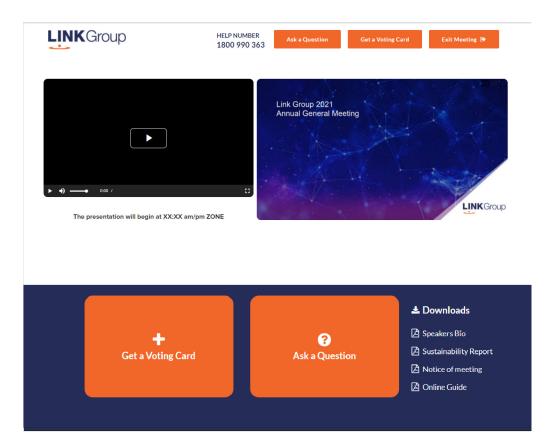


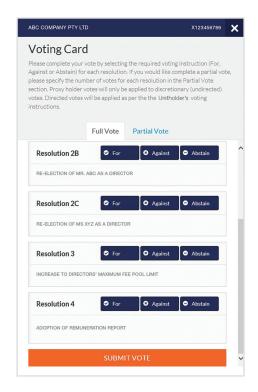
If you are an individual or joint securityholder you will need to register and provide validation by entering your securityholder number and postcode.

If you are an appointed Proxy, please enter the Proxy Number issued by Link in the PROXY DETAILS section. Then click the **'SUBMIT DETAILS AND VOTE'** button.

Once you have registered, your voting card will appear with all of the resolutions to be voted on by securityholders at the Meeting (as set out in the Notice of Meeting). You may need to use the scroll bar on the right hand side of the voting card to view all resolutions.

Securityholders and proxies can either submit a Full Vote or Partial Vote.





Full Votes

To submit a full vote on a resolution ensure you are in the 'Full Vote' tab. Place your vote by clicking on the 'For', 'Against', or 'Abstain' voting buttons.

Partial Votes

To submit a partial vote on a resolution ensure you are in the 'Partial Vote' tab. You can enter the number of votes (for any or all) resolution/s. The total amount of votes that you are entitled to vote for will be listed under each resolution. When you enter the number of votes it will automatically tally how many votes you have left.

Note: If you are submitting a partial vote and do not use all of your entitled votes, the un-voted portion will be submitted as No Instruction and therefore will not be counted.

Once you have finished voting on the resolutions scroll down to the bottom of the box and click on the **'Submit Vote'** or **'Submit Partial Vote'** button.

Note: You can close your voting card without submitting your vote at any time while voting remains open. Any votes you have already made will be saved for the next time you open up the voting card. The voting card will appear on the bottom left corner of the webpage. The message **'Not yet submitted'** will appear at the bottom of the page.

You can edit your voting card at any point while voting is open by clicking on 'Edit Card'. This will reopen the voting card with any previous votes made.

At the conclusion of the Meeting a red bar with a countdown timer will appear at the top of the Webcast and Slide windows advising the remaining voting time. Please make any changes and submit your voting cards.

Once voting has been closed all submitted voting cards cannot be changed.

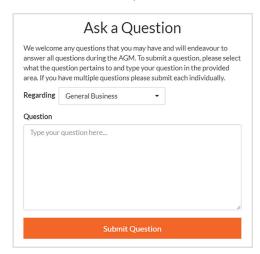

2. How to ask a question

Note: Only securityholders are eligible to ask questions.

If you have yet to obtain a voting card, you will prompted to enter your securityholder number or proxy details before you can ask a question. To ask a question, click on the 'Ask a Question' button either at the top or bottom of the webpage.

The 'Ask a Question' box will then pop up with two sections for completion.



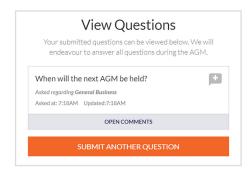
In the 'Regarding' section click on the drop down arrow and select the category/resolution for your question.

Click in the 'Question' section and type your question and click on 'Submit'.

A 'View Questions' box will appear where you can view your questions at any point. Only you can see the questions you have asked.

If your question has been answered and you would like to exercise your right of reply, you can submit another question.

Note that not all questions are guaranteed to be answered during the Meeting, but we will do our best to address your concerns.

4. Voting closing

Voting will end 5 minutes after the close of the Meeting.

At the conclusion of the Meeting a red bar with a countdown timer will appear at the top of the Webcast and Slide screens advising the remaining voting time. If you have not submitted your vote, you should do so now.
