Distributions will be calculated based on the number of units held by you as at the record date i.e. your distribution entitlement will not be pro-rated having regard to the duration of your investment in PIXX during the financial year. It is important to note that the estimated distribution calculated for PIXX will lead to an equivalent reduction in PIXX's unit price from the ex-distribution date.

If you have not provided your bank account details or made an election to participate in the Dividend Reinvestment Plan ("**DRP**") by 5pm on 30 June 2021, your distribution will be automatically reinvested in accordance with the constitution of PIXX and the rules of the DRP.
