The interim financial report was authorised for issue on 25 February 2021 by the Directors, who have the power to amend and re-issue the interim financial report.

#### Platinum Asia Fund (Quoted Managed Hedge Fund) Responsible Entity Report 31 December 2020

The Directors of Platinum Investment Management Limited (trading as Platinum Asset Management®) (ABN 25 063 565 006 AFSL 221935), the responsible entity of the Platinum Asia Fund (Quoted Managed Hedge Fund) ("PAXX", the "registered scheme" or "Fund"), present their report on the registered scheme for the half-year ended 31 December 2020.

#### **Principal Activities**

The Platinum Asia Fund (Quoted Managed Hedge Fund) (ASX code: PAX) is an Australian registered managed investment scheme. Its units are quoted on the Australian Securities Exchange (ASX) under the ASX AQUA Rules.

The Fund is an ASX-quoted version of the unlisted flagship fund Platinum Asia Fund ("PAF"). PAXX is a feeder fund that primarily invests in units of PAF, giving investors access to PAF's portfolio composition, portfolio managers and investment strategies. The returns of PAXX may vary slightly from the returns of PAF's performance fee P Class due to different cash holdings and as well as gains and losses on redemptions of PAXX units.

The principal activity of PAXX during the half-year was to invest in units of the PAF and some cash. The underlying fund, or PAF, invests in the securities of companies listed on stock exchanges throughout the world, in accordance with the Product Disclosure Statement (PDS) and the Constitution.

#### **Directors of the Responsible Entity**

The Directors of Platinum Investment Management Limited ("PIML") during the half-year and up to the date of this report, were:

There were no significant changes to the state of affairs of the registered scheme during the half-year.

#### Operating and Financial Review (OFR)

At 31 December 2020, PAXX's Funds Under Management ("FUM") was \$183.0 million¹ (30 June 2020: \$143.5 million). The six month return for the period from 1 July 2020 to 31 December 2020 was 19.8%² (1 July 2019 to 31 December 2019: 6.7%). The benchmark Morgan Stanley Capital International All Country Asia excluding Japan Net Index (MSCI) in A\$ terms for the same period was 17.1% (1 July 2019 to 31 December 2019: 6.6%). The Fund's annualised return since inception date³ on 12 September 2017 to 31 December 2020 was 13.5% (compound per annum), which is above the MSCI which delivered 10.9% since inception.

As at 31 December 2020, PAXX's Net Asset Value per unit was \$5.6519 (30 June 2020: \$4.7168 after the 30 June 2020 distribution).

<sup>1</sup> The reason for the variance between the FUM figure of \$183.0 million and the net assets figure of \$182.6 million reported in the financial statements relates to the fact that net assets were calculated in accordance with the Australian Accounting Standards and are valued using the redemption price as at 31 December 2020.

In terms of outlook, the Investment Manager has recently noted that:

"We believe that with a lessening of global trade tensions and the distribution of vaccines over the course of 2021, we are likely to see an ongoing global recovery. We would highlight that the strong data, commodity price and currency movements... come amid ongoing lockdowns and disruption in major economies, both in Asia and globally, and the recovery cited is likely to gain momentum as major economies emerge from these disruptions. We are likely to continue to pivot the portfolio toward more value and economically sensitive exposures, such as industrials and financials, with a view to the potential for a robust synchronous recovery globally."

#### Rounding of amounts to the nearest thousand dollars

The registered scheme is of a kind referred to in ASIC Corporations "Rounding in Financial/Directors' Reports" Instrument 2016/191, issued by the Australian Securities and Investments Commission, relating to 'rounding-off'.

#### Note 1. General information

Platinum Investment Management Limited ABN 25 063 565 006 AFSL 221935 is the responsible entity of the registered scheme. The registered office is Level 8, 7 Macquarie Place, Sydney, NSW 2000.

#### Note 2. Basis of preparation of the interim financial report

This financial report for the interim reporting period ended 31 December 2020 has been prepared in accordance with Australian Accounting Standard AASB 134 *Interim Financial Reporting* and the *Corporations Act 2001*. Compliance with AASB 134 ensures compliance with International Financial Reporting Standard IAS 34: *Interim Financial Reporting*.

These financial statements for the half-year ended 31 December 2020 do not include all the notes of the type normally included in an annual financial report. Accordingly, this report is to be read in conjunction with the financial report for the year ended 30 June 2020 and any public pronouncements made in respect of the registered scheme during the interim reporting period.

The accounting policies are consistent with those of the previous financial year and corresponding interim reporting period, unless otherwise stated. Comparative information has been reclassified, where appropriate, to enhance comparability.

New Accounting Standards and Interpretations

There are no standards that are not yet effective that are expected to have a material impact on the registered scheme in the current or future reporting periods and on foreseeable future transactions.

#### Note 5. Fair Value Hierarchy

- a) quoted prices (unadjusted) in active markets for identical assets or liabilities (level 1);
- b) inputs other than quoted prices included within level 1 that are observable for the asset or liability either directly (as prices) or indirectly (derived from prices) (level 2); and
- c) inputs for the assets or liabilities that are not based on observable market data (unobservable inputs) (level 3).

The registered scheme measures and recognises the units held in the Platinum Asia Fund, as a fair value investment, pursuant to AASB 13, on a recurring basis.

As can be seen from the table below, the registered scheme has no assets that are classified as level 3. For all other financial assets, the carrying value approximates fair value.

#### Report on the half-year financial report

#### Conclusion

We have reviewed the half-year financial report of Platinum Asia Fund (Quoted Managed Hedge Fund) (the Registered Scheme) which comprises the statement of financial position as at 31 December 2020, the statement of changes in equity, statement of cash flows and statement of comprehensive income for the half-year ended on that date, significant accounting policies and explanatory notes and the directors' declaration.
