Monthly Net Tangible Asset Update

The unaudited <u>pre-tax</u> net tangible asset (*pre-tax NTA*) backing per share of Platinum Capital Limited (*PMC*) as at 30 September 2017 was \$1.6852 (31 August 2017: 1.6361).

The unaudited post-tax net tangible asset (**post-tax NTA**) backing per share of PMC as at 30 September 2017 was \$1.5884 (31 August 2017: 1.5523).

The NTA was calculated on a liquidation basis using the last sale price to value investments. Investments were stated at net market value and for the post-tax NTA, after provision for tax on **both** realised and unrealised income and gains.

At 30 September 2017, the PMC share price was \$1.77.
